- 8. Exhibitor may not sell, sublet, or assign their display space to another Exhibitor.
- 9. Reservations and payment must be made in advance. Cancelled checks will serve as receipt, or send a self-addressed stamped envelope. We kindly request that Exhibitors provide an e-mail address for confirmation
- 10. No unreasonable noise, disruptive or abusive behavior will be tolerated.
- 11. Exhibitors must remain at their space and demonstrate professionalism at all times.
- 12. NO Exhibitor will leave the Flea Market before 4:00 pm. NO vehicle will be allowed on the lawn before 7:00 am.
- 13. All contracts must be filled out completely and all rental fees must be received by September 1, 2019.
